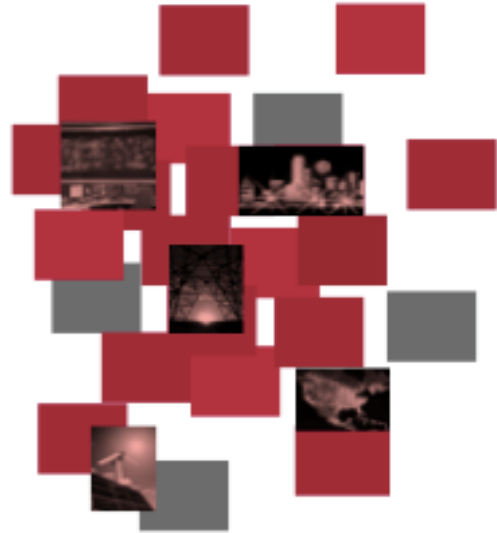
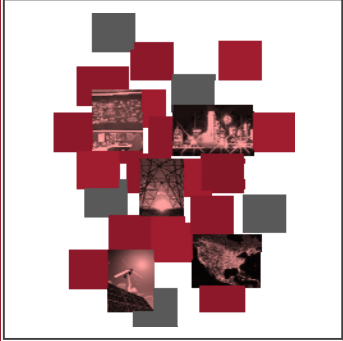

Improving electric system reliability is an increasing focus of Federal regulation (FERC) and industry oversight through entities such as the North American Electric Reliability Corporation (NERC) and the Electric Reliability Organization (ERO). As such, Registered Entities (RE) are encouraged to implement robust Internal Compliance Programs (ICP) that support reliability on a forward-looking (rather than reactive) basis.
